JOINT RESOLUTION

Removing the deadline for the ratification of the equal rights amendment.

1 *Resolved by the Senate and House of Representatives*
 2 *of the United States of America in Congress assembled (two-*
 3 *thirds of each House concurring therein), That notwith-*
 4 *standing any time limit contained in House Joint Resolu-*
 5 *tion 208, 92d Congress, as agreed to in the Senate on*
 6 *March 22, 1972, the article of amendment proposed to*
 7 *the States in that joint resolution shall be valid to all in-*
 8 *tents and purposes as part of the Constitution whenever*
 9 *ratified by the legislatures of three-fourths of the several*
 10 *States.*
